[(Min. 9 sqm)(Min. 3m x 3m)] We shall provide 1 table, 2 chairs, 2 Power Connection Point, (you may bring your own stabilizer unit if you need regulated power) 2 Spot Lights and floor carpet.

Payments: All remittances should be made through E - payment (for both Indian and Foreign Delegates). The details of remittance shall be provided to Conference Secretariat for confirmation on receipt of the same.

Terms and Conditions

1. FCRI will allot stalls to The Exhibitors on a first come first serve basis.
2. FCRI will allot stalls to the Exhibitor only on receipt of confirmation of stall booking in writing along with payment by E -payment only with duly filled in applications form.
3. All Exhibitors have to make payments by E –payment only.
4. FCRI will make appropriate security arrangements. However, FCRI shall not be liable for any loss and / or damage to Exhibitor’s equipment, display materials, samples etc., due to any reason whatsoever beyond FCRI’s control.
5. The Exhibitors shall not assign this contract or any part thereof without FCRI’s prior written consent.
6. The Exhibitor will take care of the flooring, walls and all other structures during the stall decoration and also while bringing and removing the materials. On these matters follow such instructions as given by FCRI from time to time. This is the essence of the contract.
7. The Exhibitors shall ensure that no hazardous or inflammable materials are kept in the stall and also ensure to adopt adequate safety measures in this regard.
8. The Exhibitors shall make good to FCRI all cost, damages and expenses, resulting from fire or any damage caused to the structure, etc. due to Exhibitor’s negligence.
9. The Exhibitors shall ensure that all demonstrations, interviews, advertising, promotion and other sales & Marketing activities are conducted within the stalls and aisles must always be kept clear for the visitors.
10. Audio / Visual displays may be conducted within the stalls without disturbing the other Exhibitors.
11. The Exhibitor must ensure that interior decoration of stalls is completed before the inauguration as per the time indicated in the schedule, which will be given to the Exhibitor upon confirmation of participation.
12. Every Exhibitor shall ensure that his space is open to view and staffed by competent representatives during exhibition hours.
13. If the Exhibitor commits any breach of the contract and fails to remedy it promptly on receiving written notice form FCRI, then the FCRI may, by a written notice, terminate this contract. Upon termination under this clause of otherwise the Exhibitor will forthwith vacate possession of the same. The exercise of right under this clause will not prejudice any rights of FCRI.
14. The Parties agree that competent courts at palakkad only shall have exclusive jurisdiction in all disputes arising under this contract.
15. Exhibitor to ensure that the stall is vacated with all the items exhibited at the closure of the 3 day program at their own cost and with their own Transport arrangements.
